Description: This course is designed to prepare the new Infection Preventionist or person responsible for Infection Prevention and Control to perform the duties required in various types of healthcare settings.

1. Identify the modes of transmission, incubation periods, host resistance, and susceptibility to various infections and infectious diseases.
2. Implement appropriate measures to prevent the spread of infection.
3. Discuss governmental regulations and standards which govern infection prevention practice.
4. Define criteria for identifying healthcare-associated infections.
5. Describe the processes used in sterilization, disinfection, and sanitation in healthcare facilities.
6. Present the management and communication skills necessary for the coordination of an effective infection prevention program.
