Influenza Activity Summary
Week Ending October 24, 2009(MMWR Week 42)

Influenza Activity Level: **WIDESPREAD**

NOTE: Two of three reporting parameters are above state baseline. Eight counties have 2 of 3 parameters above state baseline and 14 counties have had culture/PCR positive samples in the last 3 weeks. Five counties have had both positive culture/PCR and 2 of 3 parameters above baseline.

No Activity- At least 2 of 3 parameters at or below state baseline **AND** no lab confirmed cases

Sporadic – At least 2 of 3 parameters above state baseline **AND** confirmed laboratory cases anywhere in the state within previous 3 weeks **OR** at least one laboratory confirmed outbreak in an institution anywhere in the state

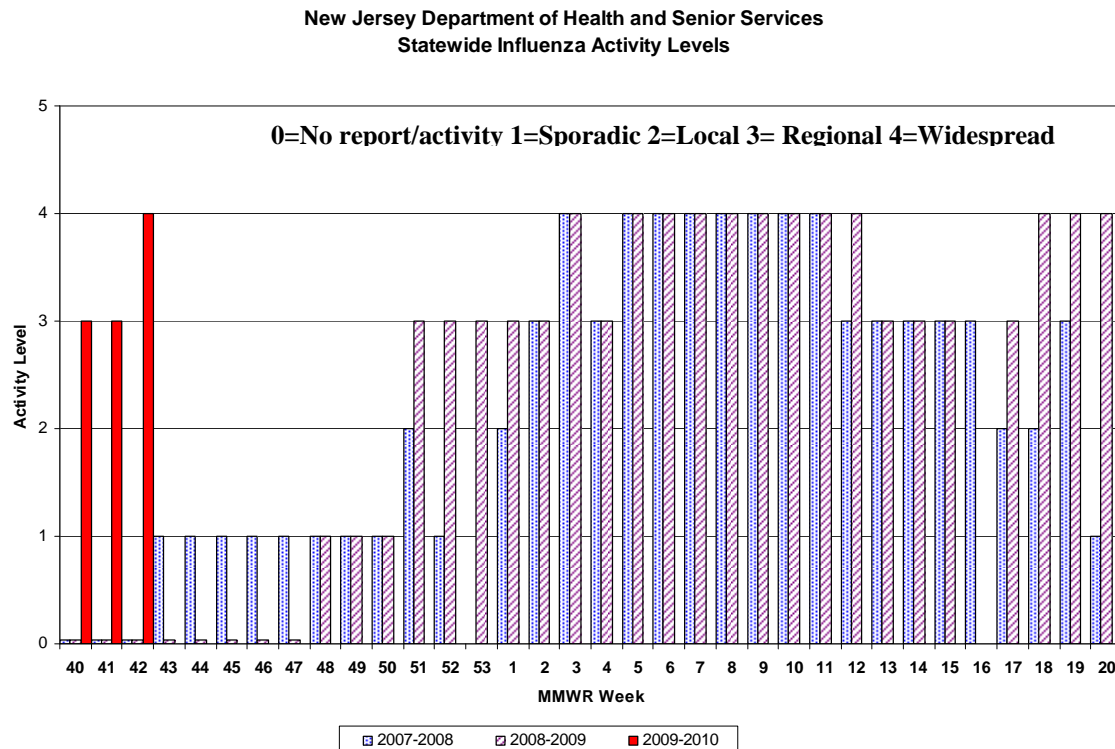
Local – At least 2 of 3 parameters above state baseline in a single county **AND** confirmed laboratory cases from that same county within the previous 3 weeks (other counties may be above baseline without lab confirmed cases) **OR** confirmed outbreaks in 2 or more institutions in a single county

Regional – At least 2 of 3 parameters above state baseline in ≥ 2 but ≤ 10 counties **AND** laboratory confirmed cases from these same counties in the past 3 weeks **OR** confirmed outbreaks institutions in ≥ 2 but ≤ 10 counties

Widespread – At least 2 of 3 parameters above state baseline in > 10 counties **OR** institutional outbreaks in > 10 counties **AND** lab confirmed influenza cases in previous 3 weeks.

Parameter = School, emergency department, or long term care weekly surveillance data

Off season baseline is calculated by taking the average of statewide percentages of ILI for a 4 year (2006, 2007, 2008, 2009) period during months when influenza is less likely to be circulating (May-August).

Local – At least 2 of 3 parameters above state baseline in a single county of a public health region **AND** confirmed laboratory cases from that same county within the previous 3 weeks (other counties may be above baseline without lab confirmed cases) **OR** confirmed outbreaks in 2 or more institutions in a single county of a public health region

Regional – At least 2 of 3 parameters above state baseline in at least half of the counties of public health region **AND** laboratory confirmed cases from these same counties in the past 3 weeks **OR** confirmed outbreaks institutions in at least half of counties of public health region counties

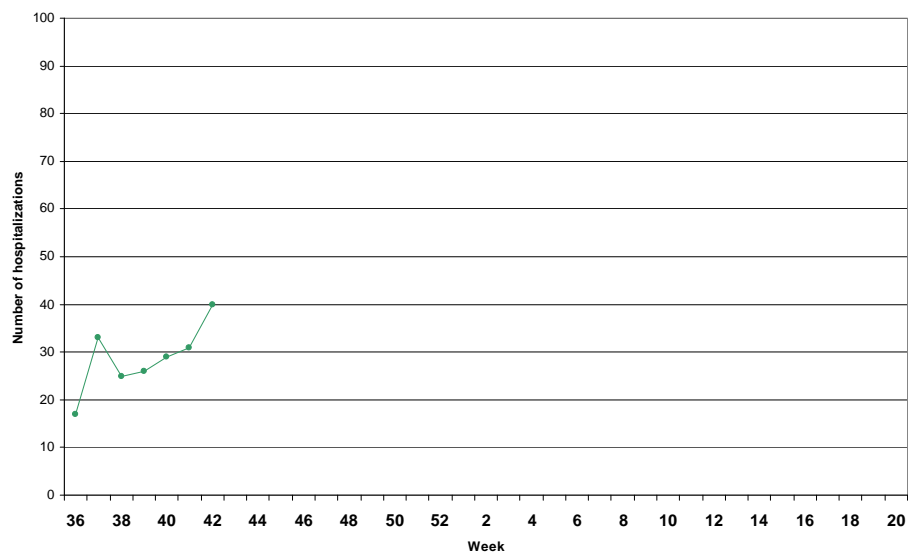

Influenza Hospitalizations/Deaths

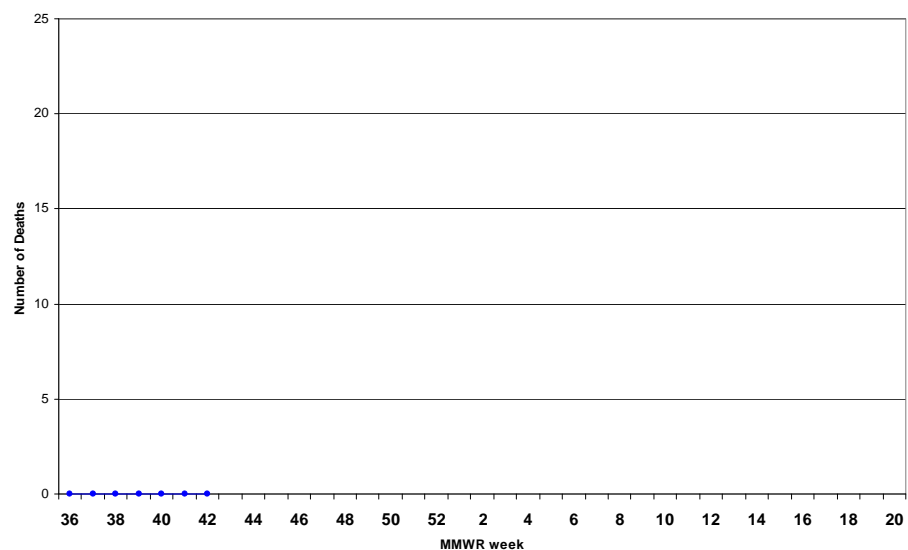
Influenza-associated hospitalizations are reported weekly from a subset of hospital facilities. Facilities report patients hospitalized with either laboratory-confirmed (rapid, PCR, culture) influenza or patients admitted with influenza-like illness. Data from influenza-associated deaths are extracted from CDRSS. Only deaths with laboratory confirmed influenza are included in these statistics.

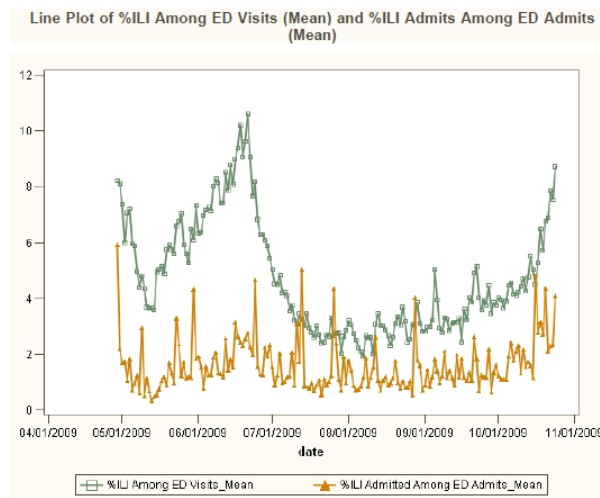


Influenza-Associated Deaths



Syndromic Surveillance – Enhanced Emergency Department (ED) Surveillance for Influenza-like Illness (ILI)

The number of ED visits, hospital admissions, ED visits due to ILI, and hospital admissions due to ILI are reported each day by acute care facilities statewide. These data are captured via daily surveys sent using the Hippocrates system.



Summary of Emergency Department (ED) Visits and Admits Surveillance

The number of ED visits and hospital admissions are reported each day by New Jersey acute care facilities statewide via daily surveys sent using the Hippocrates system. Daily surveillance for ED visits and admissions from these hospital EDs resulted in 12 ED volume blips (Atlantic, Bergen, Camden, Gloucester, Hudson, Middlesex, Salem-Cumberland and Sussex) and eight admission blips (Mercer, Middlesex, Ocean, Salem-Cumberland and Union) from 10/18/09 to 10/24/09.

Summary of Enhanced Emergency Department (ED) Surveillance for Influenza-like Illness (ILI)

During 10/18/09 – 10/24/09, 80 acute care facilities in NJ reported an aggregate total of 4,471 ED visits due to ILI (7% of total ED visits) and an aggregate total of 291 admissions due to ILI (6.5% of total ILI ED visits). These reports resulted in 27 ED ILI visit blips.

Compared to the previous week ending 10/17/09, ILI activity for the week ending 10/24/09 has been increasing. The mean percentage of ED visits for ILI during the week ending 10/24/09 was 7.1%, compared to 4.9% for the previous week ending 10/17/09 ($p < 0.0003$). The mean percentage of ED visits due to ILI ranged from 5.7% to 8.7% during 10/18/09 – 10/24/09. The mean percentage of ED visits due to ILI (averaged over the previous four influenza seasons) for this same week (MMWR Week 42) was approximately 3%.

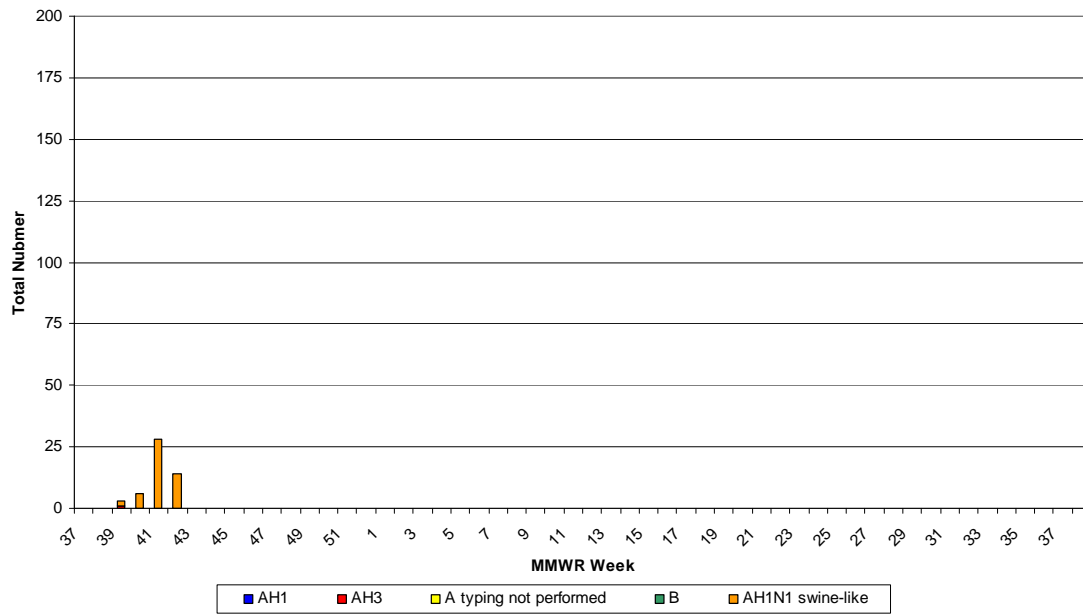
Laboratory Surveillance

As of week 42, 48 samples were found to be positive by viral culture or PCR for influenza AH1, AH3, novel AH1N1 and influenza B. Please see graph on next page for weekly distribution. Numbers of specimens tested and total number positive by rapid influenza testing are displayed by county at the end of this report.

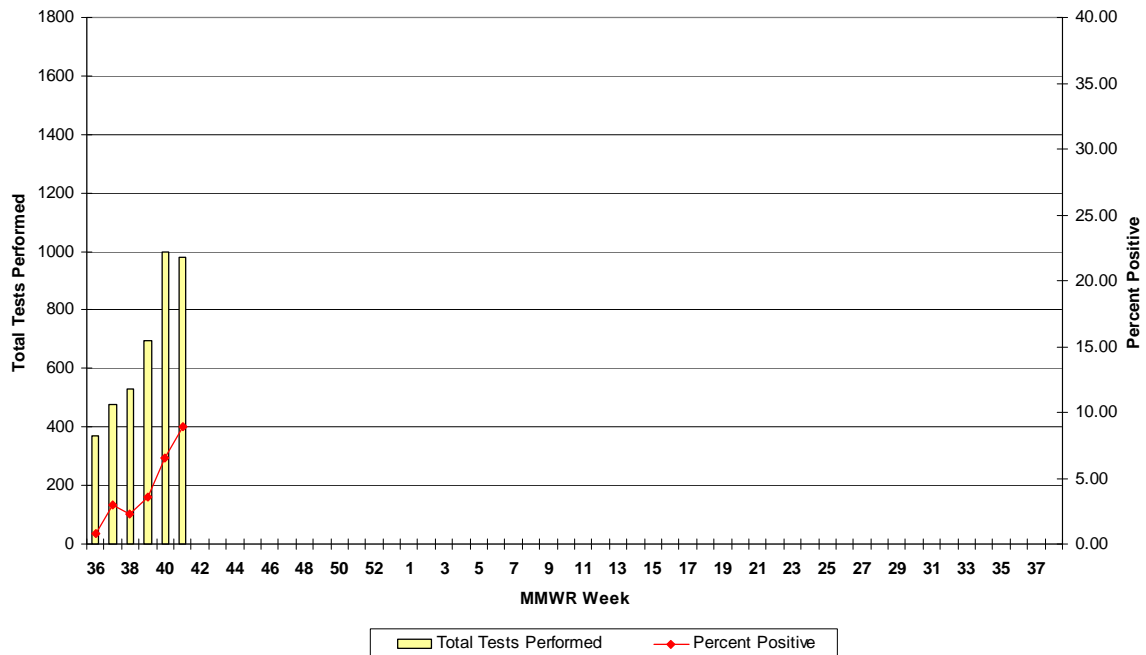

*Rapid data is acquired from facilities reporting rapid influenza tests via NREVSS or CDRSS ILI module. Culture/PCR results are obtained from the LIMS system at PHEL or hospital viral culture laboratories via NREVSS. County of residence as provided by the laboratory is used to assign culture results to a county. If county of residence is not available, the county of the facility reporting is utilized.

2008-2009 Influenza Season**

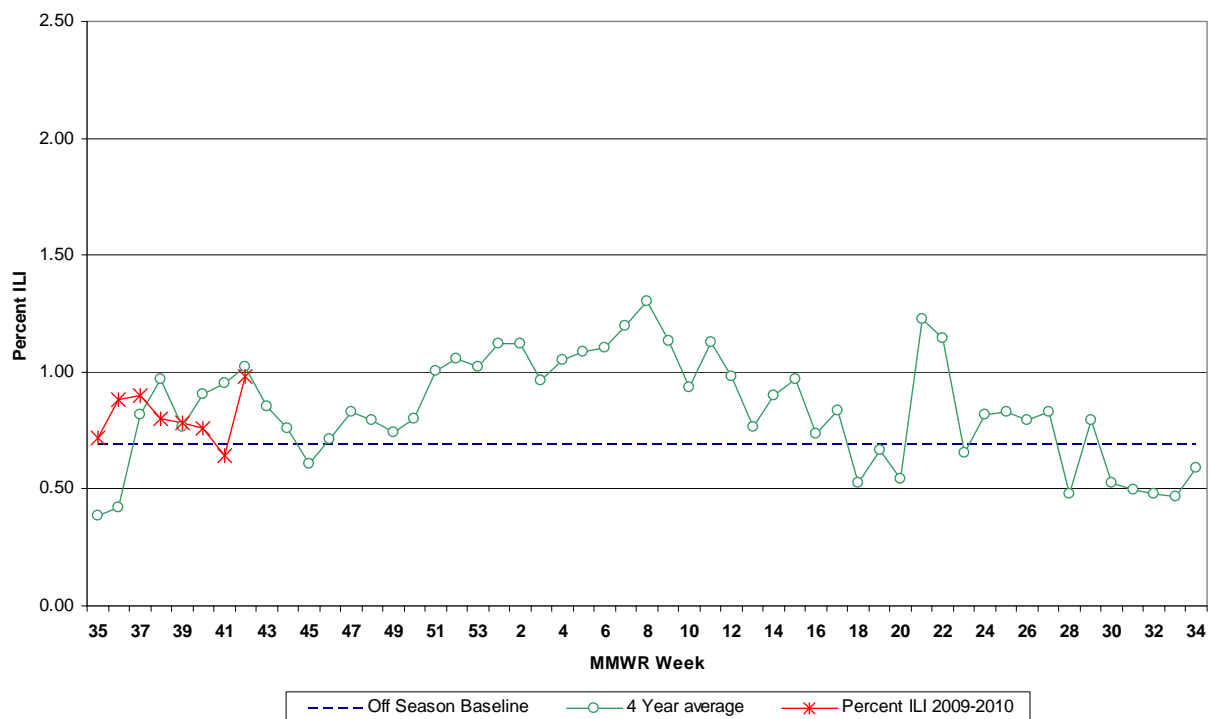


Influenza-like Illness (ILI) Surveillance*

Long-term Care Facilities

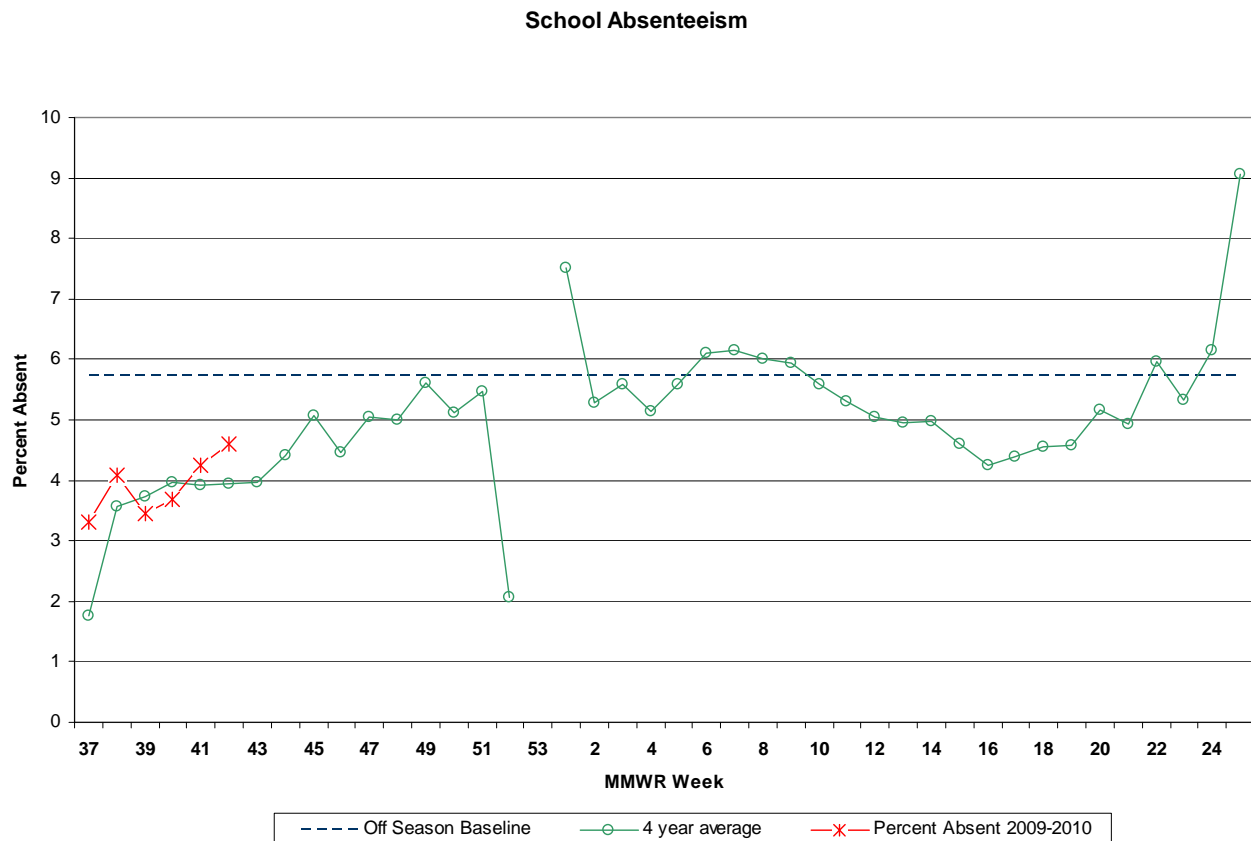
During week 42, 0.98% ILI was reported statewide from long term care facilities. This is an increase over the previous week (0.64%). The percent ILI for each county ranged from 0.00% to 3.53%. The percent ILI for this same week last year was 0.84% in long-term care facilities. The percent ILI for the northwest (1.70%), northeast (0.95%), central west (0.78%) and south (0.91%) public health regions were above the state baseline (0.69%). One respiratory outbreak in an institutional setting was received in week 42.

School Absenteeism

During week 42, schools reported 4.60% absenteeism. This is an increase over the previous week (4.26%). The percent ILI for each county ranged from 2.47 to 11.65%. The percent absent for this same week last year was 4.10%. The percent ILI for the south (6.40%) public health region was found to be above the state baseline (5.73%).

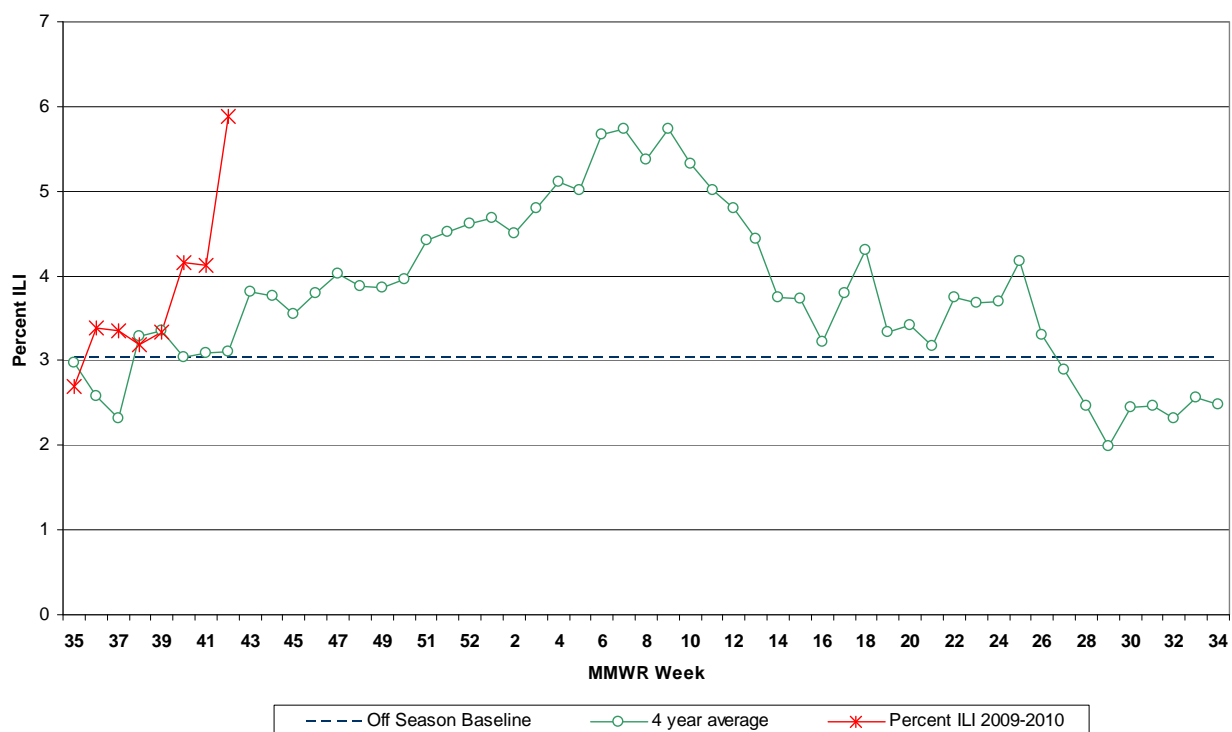


Emergency Departments

NOTE: Data presented below is from daily ED data extracted from Hippocrates survey responses for Tuesday of each week. Because this data only represents one day of data, it is likely less accurate for detecting true trends than the syndromic data presented above.

During week 42, 5.89% of ILI was reported statewide from emergency departments. This is an increase over the previous week (4.13%). The percent ILI for each county ranged from 0.62 to 21.43%. The percent ILI for this same week last year was 2.86% in emergency departments. The percent ILI for the northwest (8.00%), northeast (3.16%), central west (8.38%), central east (5.99%), and south (6.96%) public health regions were above the state baseline (3.04%).

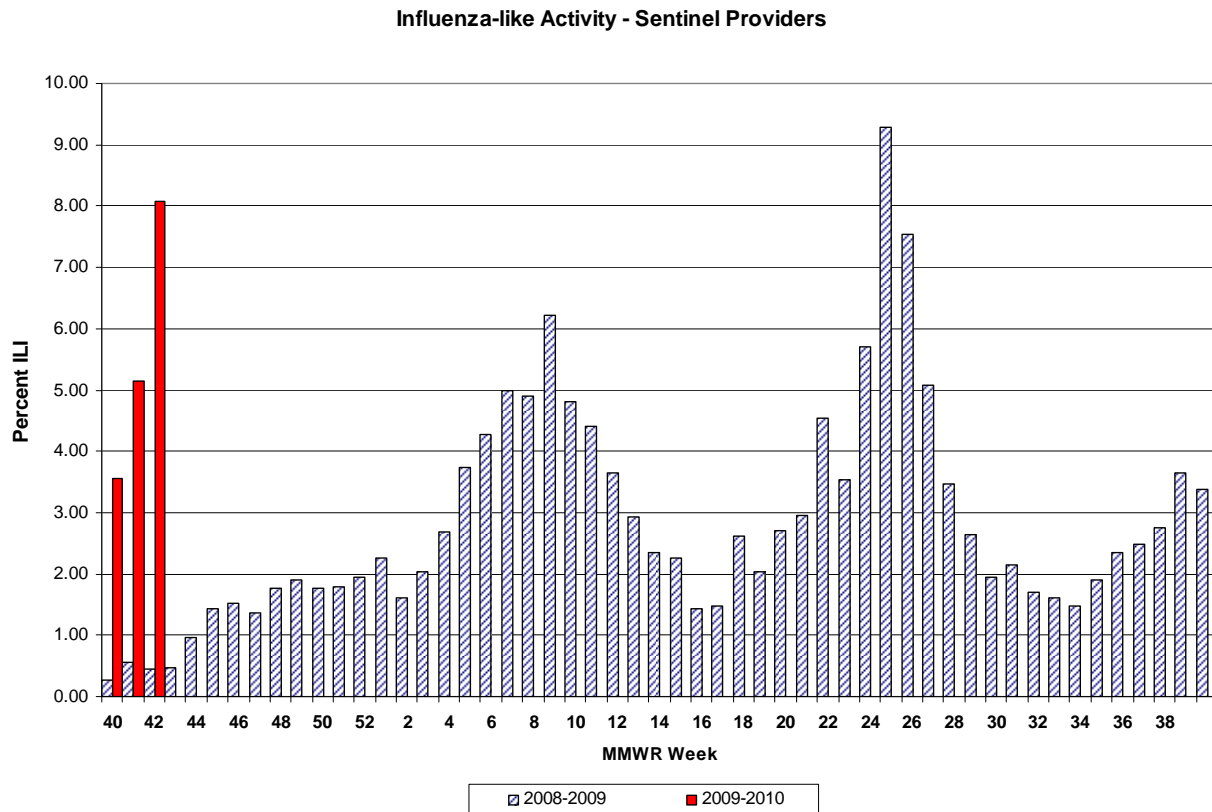
Influenza-like Activity - Emergency Departments



Sentinel Provider Surveillance

During week 42, 8.07% of sentinel provider patient visits were due to ILI. These data reflect reports from twenty (26%) of the enrolled sentinel providers.

During week 41, 5.14% of sentinel provider patient visits were due to ILI. These data reflect reports from twenty-four (31%) of the enrolled sentinel providers.



Pediatric Influenza Surveillance

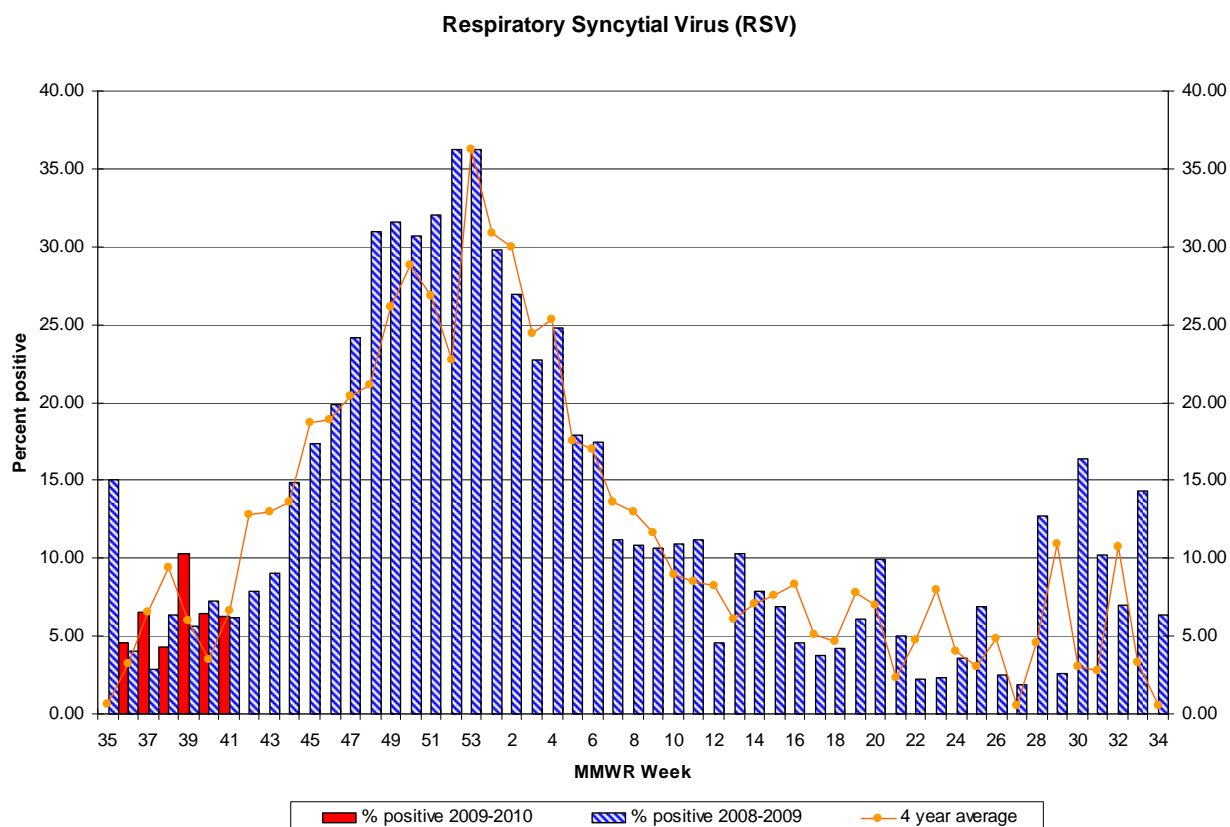
To date, NJDHSS has received 4 reports of pediatric influenza meeting the case definition.

122 City Mortality Report

During week 41, 3.61% of all deaths reported by the vital statistics offices in 6 New Jersey cities (i.e., Camden, Elizabeth, Jersey City, Newark, Paterson, Trenton) were due to pneumonia or influenza. This is a decrease over the previous week (5.71%). The percentage of death due to pneumonia or influenza for this same week last year was 3.67%.

RSV Reports

During week 41, 6.64% of all RSV samples tested were positive. This is an increase over the previous week 3.47%. The percent of samples positive for RSV for this same week last year was 6.19%.
