#### • Report of the Professional Conduct Committee: Jorge Berkowitz

The Committee has developed a matrix to be used to develop penalty amounts for violations. The Professional Conduct Committee has made some minor changes to the Penalty Matrix that was passed out to the Board earlier. The changes are as follows:

Definition of low conduct was changed from "action or omission of the LSRP was inadvertent or unintentional" to "inadvertent, unintentional"

Medium conduct was changed from "Action or omission of the LSRP was inadvertent or unintentional but the outcome was foreseeable" to "demonstrated negligence, lack of understanding of responsibilities, regulations, guidance, laws, policy, etc."

High conduct was changed from "Action or omission of the LSRP was intentional, deliberate, purposeful, knowing, willful or habitual" to "intentional, deliberate, knowing or willful act or omission, repeat violation, intentional deception"

Low severity was changed from "No impact to public health and safety and the environment" to "no impact to public health or the environment"

Medium severity was changed from "Some impact to public health and safety or the environment" to "some potential or real impact to environment. NO impact to public health"

High severity was changed from "Significant impact to public health and safety or the environment" to "impact to environment, potential or real impact to public health"

Jorge Berkowitz will make some edits for clarity to the document, and will circulate to Board Members for review prior to the next Board meeting.
