# **COLONEL YVONNE L. MAYS**

Colonel Yvonne L. Mays currently serves as the Deputy Adjutant General for New Jersey. She is the principal advisor to the Adjutant General and Commissioner of the New Jersey Department of Military and Veterans Affairs on all matters concerning military readiness, mobilizations, homeland security, defense support to civil authorities, human resources, logistics, training, and financial management. The duties include the supervision and management of the Department's 3,200 full-time State and Federal employees, and more than 30 armories and associated properties.

Prior to her current assignment, Colonel Mays served as the Director of Staff, New Jersey Air National Guard, where she was the principal advisor to the Adjutant General of the State of New Jersey on all matters concerning the 108th Air Wing, the 177th Fighter Wing, subordinate units and civilian matters pertaining to the New Jersey Air National Guard. Colonel Mays began her National Guard career as the Director of Personnel and Commander of the Mission Support Flight, Atlantic City Air National Guard Base, 177th FW in 1999. In 2003, she went on to be the 177th FW Executive Officer before moving on to become the Deputy Chief of Staff, New Jersey Air National Guard in 2008. In 2009, Colonel Mays was appointed as the Public Affairs Officer for the New Jersey Department of Military and Veterans Affairs. In 2010, she became the first female officer to serve as the Bilateral Affairs



Officer to the New Jersey National Guard's State Partner, the Republic of Albania. Prior to commissioning and while serving as an enlisted Airman in the active component, she supported numerous operations such as Operation Just Cause and deployed in support of Operation Desert Storm. Colonel Mays earned her commission from the Palmetto Military Academy, Fort Jackson, South Carolina, in 1999. During her tenure as an officer in the New Jersey Air National Guard, Colonel Mays has supported Operations Noble Eagle and Enduring Freedom. Most recently she served as the Deputy to the Dual Status Commander and Deputy Joint Task Force Commander supporting New Jersey COVID-19 Response Operations.
